Dear AGS Show Sponsor,

In order to help you understand AGS's sanctioning rates and ensure a smoother running show we have provided you with new Show Rate Sheet and Checklist. Please make sure that all information is filled in and attach to your Sanction Application. Thank you!

**Fees:**

**60 or more days in advance \$20 for first sanction, \$10 for each additional sanction**

*(1 show for Seniors, Juniors and Bucks for 1 breed would be \$40 at this sanction rate)*

**59-30 days \$30 for first sanction, \$10 for each additional sanction**

*(1 show for Seniors, Juniors and Bucks for 1 breed would be \$50 at this sanction rate)*

**29-or less \$40 for first sanction, \$10 for each additional sanction, prepaid overnight postage must be included (starts at \$17.85)**

*(1 show for Seniors, Juniors and Bucks for 1 breed would be \$60 at this sanction rate, plus overnight postage)*

**Reduced Rate Sanction: \$10 per show** - this sanction includes report of awards, and judges return envelope, no ribbons or certificates. Must be filed 15+ days in advance, all other rules apply.

**Additional Breeds** per sanction \$5 each

**To Sanction all 9 breeds: Sr doe, Jr Doe, Bucks the cost would be \$160**

**\*\*Rules and Classes EXACTLY as being used, are required to be turned in with your sanction request. The base date for computing sanction fees is when all materials (rules, classes, judges fees) are received in office. EX: If you send a sanction request 60+ days in advance but fail to provide office with rules, classes or judges fees until 30 days before the show your base sanction rate would be \$30**
